- 1 APOLOGIES Coun. Mike Mears,
- 2 DECLARATIONS OF INTEREST There were none
3. MINUTES OF PREVIOUS MEETING HELD ON JUNE 20, 2018 were accepted as circulated and signed by the chairman
- 4 CLERK'S REPORT
The council discussed the proposed flagpole for the village hall grounds and agreed on one to be 20ft above
The clerk said that grass cutting for the playing field had been organised for the summer with the school.
5. REPORT FROM THE DISTRICT AND COUNTY COUNCIL MEMBER
There was no report
6. DEFIBRILATOR
Coun. Gordon said there were no problems to report. A letter from Community Heartbeat advised the council of the need to ensure the cleanliness of the cPAD cabinets, saying if they were not kept clean members of the public would not have confidence on the ability of the device to work At least one ambulance service has said they will delist sites that are not kept clean. Coun. Gordon said he checked the defib in the village every three or four weeks and was happy with its condition.
7. VILLAGE HALL
The chairman reported that the Village Open Day had been successful and had made a profit of over £700, being shared by the parish church and the village hall.

Rushcliffe Borough Council advised of their free Tree scheme for parishes, saying up to ten would be available per council and which had to be ordered by 30 September.
Notts County Council chairman Coun. Sue Saddington, gave note of a Charity evening hog roast she was organising on Sept 15 at Muskham, in aid of the Children's Hospital.
Mike Mears said the Humphreys were not able to assist in respect of the production of a tower for a beacon but he had been given the name of another farrier who might help and would make contact.
National Seafarer wrote in respect of the council purchasing a Red Ensign flag to fly but members declined to do so.

They are concerned over the impact on the adjacent road by the scheme and of the proposed siting of the development, feeling it should be adjacent to the existing development on site.
