

**Minutes of a meeting of Costock Parish Council held on Wednesday June 20, 2018
in the Village Hall at 7.30pm**

1. APOLOGIES WITH REASONS TO BE APPROVED BY THE COUNCIL Coun. Peter Gordon, Phil Lilley and Everard Robinson.
2. DECLARATIONS OF INTEREST There were none
3. MINUTES OF PREVIOUS MEETING HELD ON MAY 16, 2018 were accepted as circulated and signed by the chairman
4. CLERK'S REPORT
Trees scheme by Rushcliffe Borough Council - - suggested sites needed and members were asked to come forward with suggestions.
Royal wedding telegram – an item had appeared in the Loughborough Echo.
The chairman and the clerk will be attending a meeting the following day at Rushcliffe Borough Council when further details will be given in respect of the Tour of Britain cycle race which will pass through Costock on September 8. The timing is not currently known when the 120 international cyclists taking part will enter Costock from the direction of East Leake and go on to Wysall. There will be a clearance of all road vehicles on the route in Costock 2 hours before, no exceptions, and if necessary vehicles could be towed away. During the hour before 50 police motorcyclists will start coming along, parking themselves at every junction on the route through the village. Half an hour before the cyclists reach the village the road will be closed to all traffic. Finally, the car and motorcycles leading the race will come through closely followed by the riders travelling at about 30mph. Following the riders will be team cars and other race officials. By the time the riders have passed through there will have been over a hundred cars and motorcyclists passing through with them. The race will be live on ITV4. All villages on route are being urged to show support for the event and look to finding ways to celebrate what will be a very important day for each village. The Rushcliffe meeting will be putting out ideas for what might be arranged, and it was agreed the council consider what they might organise.
5. REPORT FROM THE DISTRICT AND COUNTY COUNCIL MEMBER
Coun. Cottee said he was still asking for the condition of Church lane and Chapel Lane to be improved.

9. CORRESPONDENCE
Notts County Council gave advice of its Great War Heritage Day on Wednesday July 11 at Rufford Abbey County Park 10am – 3pm.
Armed Services Day is on June 30 and it was agreed the special flag be displayed on the railings to the hall. The clerk was asked to investigate the purchase of a flag pole for siting near the railings at the village hall, it being pointed out that the existing pole on the hall itself was difficult to reach.
